This Sunday, Nov. 28th is our Advent Communion Service. It is also the first time that our Discovery Kids will be back worshipping with us and having their time together in-person at the church. Starting this Sunday, until the end of Jan. they will gather at the church on the 2nd and 4th Sundays, with Zoom gatherings on the 1st and 3rd Sundays.

I want to thank the members of the Worship committee and Bible Study who helped to decorate the sanctuary and atrium for our Advent/Christmas celebrations.



Feedback that we are receiving from those who are attending in-person worship indicates that people feel very safe. We are all wearing masks, socially distancing and are quite separated from one another in the pews. Pre-registration is no longer required.

St. Paul's policy requires that all eligible congregants, volunteers, user groups and visitors be fully vaccinated against Covid-19 and show proof of vaccination before entering the building. Those who wish to claim a Human Rights-Code exemption (such as a medical exemption), should notify the office of their accommodation request and guidance will be provided about how to proceed. Children not eligible for vaccination are welcome to attend! One member of the party will complete contact information for those attending with them. Masking, physical distancing and hand sanitizing is still required and singing will not resume. We are required by the Simcoe Muskoka District Health Unit to continue active screening, therefore the COVID screening questionnaire is

attached. **Please review it before you attend church on Sunday**, as the ushers will be asking you about your current health status.
